

## **Saltash U3A Privacy Policy**

Saltash U3A treats your privacy rights seriously. This privacy policy sets out how we will deal with your 'personal information', that is, information that could identify, or is related to the identity of an individual.

### **WHAT PERSONAL INFORMATION DO WE COLLECT ?**

When you express an interest in becoming a member of Saltash U3A you will be asked to provide certain information. This includes:

- Name
- Home address
- Email address
- Telephone number
- Subscription preferences
- Permission for photographs, that may include you on Group Activities, to be published

### **HOW DO WE COLLECT THIS PERSONAL INFORMATION ?**

All the information collected is obtained directly from you. This is usually at the point of your initial registration. The information will be collected via membership forms or online contact forms. The lawful basis for collecting and storing your information is due to the legitimate interest that Saltash U3A has in communicating with you as a member / contractual relationship that you, as a member, have with the U3A. In order to inform you about groups, activities and events that you can access as a member we need to store and process a certain amount of personal data.

### **HOW DO WE USE YOUR PERSONAL INFORMATION ?**

We use your personal information:

- To provide our U3A activities and services to you
- For administration, planning, and management of our U3A
- To communicate with you about your group activities
- To monitor, develop and improve the provision of our U3A activity
- For the delivery of the Trust publication - Third Age Matters

We may send you messages by email, other digital methods, telephone and post to advise you of U3A activities.

## **WHO DO WE SHARE YOUR PERSONEL INFORMATION WITH ?**

We may disclose information about you, including your personal information:

- Internally - to committee members and group conveners - as required to facilitate your participation in our U3A activities.
- Externally - The Third Age Trust magazine is distributed by a third party processor and your information is shared with the distribution company via an online portal. Should you **NOT** wish to receive the magazine please contact the Membership Secretary.
- If we have a statutory duty to disclose it for legal and / or regulatory reasons. In this instance we will seek to obtain your consent. Information would be shared without consent where there were serious safety concerns and it was felt to be in your or the U3A's best interest to disclose information.

## **HOW LONG DO WE KEEP YOUR PERSONAL INFORMATION ?**

We need to keep your information so that we can provide our services to you. In most instances information about your membership will be stored for as long as you remain a member. If membership not renewed details will be deleted after 12months. The exceptions to this are instances where there may be financial, legal or insurance circumstances that require information to be held for longer whilst the issues are investigated or resolved. Where this is the case member/s will be informed as to how long the information will be held for and when it has been deleted.

## **HOW YOUR INFORMATION CAN BE UPDATED OR CORRECTED ?**

To ensure the information we hold is accurate and up to date, members need to inform the U3A as to any changes to their personal information. You can do this by contacting the membership secretary on email: [members@saltashu3a.org.uk](mailto:members@saltashu3a.org.uk) or at a monthly meeting.

On an annual basis you will have the opportunity to update your information, as required, via the membership renewal process. Should you wish to view the information that Saltash U3A holds on you, you can make this request by contacting the membership secretary - as detailed above. There may be certain circumstances where we are not able to comply with this request. This would include where the information may contain references to other individuals or for legal, investigative or security reasons. Otherwise we will usually respond within one month of the request being made.

## **HOW DO WE STORE YOUR PERSONAL INFORMATION ?**

Saltash U3A has in place a range of security safeguards to protect your personal information against loss or theft, as well as unauthorised access, disclosure, copying, use or modification. Security measures include use of cloud storage, firewalls, use of a management database system. Your membership information is held securely and accessed by Committee Members and Group Conveners - as appropriate.
